This contract shall be interpreted using Alabama law with jurisdiction and venue for any and all legal remedies being Limestone County, Alabama. Furthermore, said exhibitor shall release BK Productions, LLC officers and staff of any liability whatsoever resulting in cancellation of the exhibitor's space for said show.
